NATIONAL AFFAIRS

- Indian Army's Exercise Topchi 2023 held in Devlali, Maharashtra; Made-in-India Weapons showcased: Indian Army's 'Exercise Topchi 2023', the annual firepower demonstration and training exercise, was conducted by the School of Artillery at the Devlali field firing ranges, in Devlali, Nashik, Maharashtra. The highlight of the exercise was the display and firing of indigenously manufactured (Made in India) Artillery equipment. The event was conducted under the stewardship of Lt Gen S Harimohan Iyer, AVSM, Commandant School of Artillery and Col Commandant Regiment of Artillery.
- 2. First G20 International Financial Architecture Working Group Meeting Held in Chandigarh: On January 30 31, 2023, the first "G20 International Financial Architecture Working Group Meeting" under the G20 (Group of Twenty) Indian Presidency was held in the Union Territory of Chandigarh. India assumed the G20 Presidency for a year, from December 1, 2022 to November 30, 2023. The "International Financial Architecture Working Group" is focused on addressing ways to strengthen the international financial architecture, improve finance for development, and address vulnerabilities in the global financial system.
- 3. CMIE: Unemployment Rate Falls to 4-Month Low of 7.14% in January: According to the data from the Centre for Monitoring Indian Economy (CMIE), India's unemployment rate declined by 7.14% in January 2023, the lowest in 4 months, from 8.30% in December 2022. The unemployment rate was 8.03% in November 2022, 7.92% in October 2022 and 6.43% in September 2022. Rural unemployment was 6.48% in January 2023, and Urban unemployment was 8.55%. Jammu and Kashmir had the highest unemployment rate among the states with 21.8%, followed by Haryana (21.7%), and Rajasthan (21.1 %). Chhattisgarh is the lowest unemployment rate among the states with 0.5%, followed by Odisha (1.5%), Tamil Nadu (1.8%), and Madhya Pradesh (1.9%).
- 4. India's 1st Hydrogen Train Will Come by Dec 2023 On Heritage Routes: Union Railway Minister Ashwini Vaishnaw announced that India's first hydrogen train will be designed and manufactured in India by December 2023, as the Union Budget 2023–24 focuses on green growth. Once operational, the hydrogen train will operate on heritage circuits such as Kalka-Shimla before being expanded to other places. The Union Budget 2023-24 has an allocation of Rs. 2.41 lakh crore for Railways. The "Amrit Bharat Station" scheme will redevelop 1275 stations while also revamping the production of Vande Bharat trains.
- Coal India Arm MCL Introduces Drone Technology in Coal Mines: Mahanadi Coalfields Ltd (MCL), a premier Central Public Sector Enterprise (CPSE) under the Ministry of Coal, has introduced drone technology in coal mines by launching "VIHANGAM," a web-based portal that includes a drone and ground control system. MCL is a wholly owned subsidiary of Coal India Limited (CIL). CIL accounts for more than 80% of domestic coal output. The "VIHANGAM" portal enables authorised users to access

real-time drone video from the mine via a dedicated 40 Mbps internet lease line located near the mines.

- 6. India, France & UAE Announce Plans for Co-Operation Under Trilateral Framework: In the midst of the geopolitical unrest brought on by the conflict in Ukraine, India, France, and the United Arab Emirates (UAE) have announced an ambitious roadmap for cooperation in a wide range of fields, including defence, energy, and technology under a trilateral framework. Proposed Actions to Support the Framework: A number of trilateral events will be organized to assist the efforts during the G20 Presidency of India and the hosting of 28th session of the Conference of the Parties (COP 28) to the UN Framework Convention on Climate Change (UNFCCC) by the UAE in 2023, respectively. The three nations also decided to enhance their cooperation through projects like the Indo-Pacific Parks Partnership, headed by India & France, and the Mangrove Alliance for Climate (MAC), led by the UAE. In the context of the International Year of the Millet 2023, the three countries decided to focus on major concerns like single-use plastic pollution, desertification, and food security.
- 7. India's G20 Presidency 2023: G20 Meetings Held in February 2023: India's hosting the prestigious G20 (Group of Twenty) summit in 2023, as the country holds the G20 Presidency from December 1, 2022, to November 30, 2023. The theme for India's G20 Presidency is "Vasudhaiva Kutumbakam," which refers to "One Earth, One Family, One Future. It is taken from the Maha Upanishad, an ancient Sanskrit text. i. The G20 is the leading forum for economic cooperation on a global scale.ii.G20 Members: It has 20 members, including 19 countries: Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, the Republic of Korea, Mexico, Russia, Saudi Arabia, South Africa, Türkiye, United Kingdom (UK), United States (US), and the European Union (EU). iii. The first "G20 Energy Transition Working Group" (ETWG) Meeting under India's G20 Presidency was held in Bengaluru, Karnataka, from February 5-7, 2023. iv. The Ministry of Electronics and Information Technology (MeitY) and Meta, parent company of Facebook, have partnered for the "G20 Stay Safe Online Campaign."
 - v.Meta has also launched the #Digital Suraksha campaign to educate the youth against misinformation, with the objective of raising cyber safety awareness and protecting people from falling victim to prevailing online frauds.
- **8.** Concurrent Events of India Energy Week 2023: India hosted the AMER9, OPEC released 'World Oil Outlook 2045': India hosted the 9th Asian Ministerial Energy Roundtable (AMER9) in association with the International Energy Forum (IEF) on 7 February 2023 at the India Energy Week 2023 which was held from February 6–8, 2023, in Bengaluru, Karnataka. As per report 'World Oil Outlook 2045' released by Organisation of the Petroleum Exporting Countries (OPEC) at the India Energy Week 2023, India and China alone will account for 37% of global GDP in 2045, whereas the OECD region will account for 34%.

- 1. India invited as Theme country of Madrid International Book Fair in 2025: On 1st February 2023, Jose Maria Ridao, the Ambassador of Spain, announced that India will be invited as the focal country at the Madrid International Book Fair in 2025 in Madrid, Spain. The announcement was made during the event held at the Spain Pavilion at the 46th International Kolkata Book Fair (IKBF 2023) at Salt Lake, Kolkata, West Bengal. Spain is the theme country of the 46th International Kolkata Book Fair which will be held from 31st January 2023 to 12th February 2023.
- 2. IEA Report: India's 'LiFE' Initiative Can Save USD 440 Billion Globally in 2030: The International Energy Agency (IEA) claimed in its country report titled "LiFE lessons from India -The benefits of advancing the Lifestyle for Environment (LiFE) initiative through the G20" that if adopted worldwide, the measures specified under the LiFE initiative could save consumers around USD 440 billion in 2030, corresponding to around 5% of total fuel spending across the global economy that year. It further said that implementing India's "LiFE" initiative may help decrease worldwide carbon dioxide (CO2) emissions by more than 2 billion metric tonnes by 2030, or roughly one-fifth of the emission reduction required to reach global net-zero emissions.
- 3. India tops as most inclusive nation for religious minorities: Global Minority Report: As per the Centre for Policy Analysis' (CPA) inaugural assessment on global minorities in its' Global Minority Report', India has topped one among 110 nations for its inclusivity measures towards religious minorities. India has the highest level of religious minorities' acceptance. India is followed by South Korea, Japan, Panama, and the United States (US) at the 2nd, 3rd, 4th and 5th positions respectively.

BANKING

- **1.** Infibeam Avenues Brand CCAvenue Becomes India's First Payment Gateway Player to Process Retail CBDC Transactions: CCAvenue, the premier payments brand of Infibeam Avenues Limited (IAL), has emerged as India's first payment gateway player to process Central Bank Digital Currency (CBDC) or Digital Rupee (e-rupee) transactions for online retail merchants. In an industry- first move, CCAvenue has processed CBDC transactions for IDFC First Bank, one of India's top private sector banks, enabling CBDC online transactions in an attempt to improve the country's digital payments ecosystem. On December 1, 2022, the RBI launched its pilot project to implement CBDC or Digital Rupee (e₹) in the Retail Segment (e₹-R) with four banks in four cities, including IDFC FIRST Bank, after testing the wholesale CBDC.
- 2. RBI Data: The Number of Micro ATMs Surged in 2022, But Cash Withdrawals Dropped:

 According to data from the Reserve Bank of India (RBI), there was a sharp increase in the number of micro Automated Teller Machines (ATMs) installed all over India in 2022. However, no major increase in the value of money withdrawn through these devices has occurred since June 2022. As of December 2022, there were 14.19 lakh micro ATMs operating across India. Trend with Respect to

Micro ATMs in India: According to the RBI data, there were around 3.56 lakh micro ATMs in India by the end of 2020, and 5.9 lakh in December 2021. The total number increased by more than double to a remarkable 14.19 lakh in December 2022. Meanwhile, in December 2020, cash withdrawals amounted to Rs. 19.67 lakh crore.

- 3. Kotak Mahindra Bank Implements RBI's First Phase of Digital Rupee: Kotak Mahindra Bank Limited (KMBL) has announced the implementation of the first phase of the Central Bank Digital Currency (CBDC), referred to as the "Digital Rupee" (e₹). The "Digital Rupee" (e₹) is a legal tender equivalent to bank notes and coins but issued in a digital form by the Reserve Bank of India (RBI). The RBI has shortlisted KMBL as one of eight banks to implement a pilot project for the issuance of ecurrencies. Reliance Retail has become the first organized retail chain in India to accept the RBI-created and blockchain-based CBDC (e₹) payments at its gourmet food store, Freshpik.
- SEBI Notifies Stronger Framework for Green Bonds; Introduces Concept of Blue, Yellow Bonds: The Securities and Exchange Board of India (SEBI), India's capital market regulator, has strengthened the green bond framework by introducing "Blue" and "Yellow" bonds as new modes of sustainable finance. These bonds are subcategories of Green Debt Securities (GDS), with 'Blue Bonds' pertaining to water management and the marine sector and 'Yellow Bonds' pertaining to solar energy. Green Debt Securities (GDS) According to the regulatory framework, GDS are debt securities that are issued to raise funds for projects or assets that belong into specific categories. Sustainable Finance Sustainable finance is the process of taking environmental, social, and governance (ESG) factors into account when making financial investment decisions, resulting in increasing long-term investments in sustainable economic activities and projects.
- Phonepe Becomes India's First Fintech Platform to Support Cross-Border UPI Payments:

 PhonePe has launched support for "UPI international" payments, making it India's first fintech platform to enable cross-border Unified Payments Interface (UPI) payments. Indian users of PhonePe can utilize this feature to instantly pay foreign merchants using UPI when they are travelling abroad. UPI international UPI International is intended to make transactions safe and simple for millions of Indians travelling abroad. It supports all international merchant outlets with a local QR (quick response) code in the United Arab Emirates (UAE), Singapore, Mauritius, Nepal, and Bhutan. Highlights of 1st Bimonthly Monetary Policy of FY23; Repo Rate raised to 6.50%: The Reserve Bank of India's (RBI) Monetary Policy Committee (MPC) met on February 6-8, 2022, and released the Monetary Policy Statement, 2022-23 Resolution of the MPC which projected India's real Gross Domestic Product (GDP) growth to 6.4% for FY24 (lower than 7% in FY23) with FY24's Q1 at 7.8%, Q2 at 6.2%, Q3 at 6%, and Q4 at 5.8%. Policy Repo Rate 6.50%, Reverse Repo Rate 3.35%, Standing Deposit Facility (SDF) 6.25%, Marginal Standing Facility (MSF) Rate 6.75%, Bank Rate 6.75%, Cash Reserve Ratio (CRR) 4.50%, Statutory Liquidity Ratio (SLR) 18%.

Drone with Parachute Integrated system: i. The custom-designed UAVs have a maximum takeoff weight of 35 kg and can travel more than 60 kilometres in 60 minutes during a single mission, depending on the load.

2. 8th meeting of US-India Civil Space Joint Working Group: officials discussed on Space Collaboration: On 30 and 31 January 2023, delegates from India and the United States of America(USA) gathered at the United States (US) Department of State for the 8th meeting of the US-India Civil Space Joint Working Group (CSJWG) and discussed on collaboration in Earth and space science as well as human space exploration. Delegates: i. The U.S. delegation included officials from the Department of State, the National Aeronautics and Space Administration (NASA), the Department of Homeland Security, the Federal Aviation Administration, the United States Geological Survey and the National Oceanic and Atmospheric Administration of the Department of Commerce. ii. The Indian delegation included representatives from the Indian Space Research Organisation (ISRO), the Ministry of Environment, Forest & Climate Change, the Indian Institute of Astrophysics, the Ministry of Earth Sciences and the Ministry of External Affairs. India-US Bilateral Cooperation in Space: The NASA-ISRO Synthetic Aperture Radar (NISAR) mission, scheduled to launch in 2024, is a part of the India-US bilateral cooperation in Space.

NISAR Mission: i. NISAR is a joint Earth-observing mission between NASA and ISRO to systematically map Earth, using two different radar frequencies to monitor resources such as water, forests and agriculture. ii. NISAR will be the 1st satellite mission to measure changes in Earth's surface less than a centimetre in size using two separate radar frequencies (L-band and S-band). Note: On 30th September 2014, NASA and ISRO signed a partnership to collaborate on and launch NISAR.

- 3. NISAR": NASA-ISRO Joint Satellite to Launch in 2024 :According to the Indian Space Research Organisation (ISRO), the 'NASA-ISRO Synthetic Aperture Radar (NISAR)' will be launched from Indian soil in the first quarter of 2024, and science operations will commence 90 days after it reaches the intended orbit. NISAR is a Low-Earth orbit (LEO) observatory being developed jointly by National Aeronautics and Space Administration (NASA), United States (US) and ISRO, India. Launch Phase The NISAR Observatory will be launched on the expendable Geosynchronous Satellite Launch Vehicle (GSLV) contributed by ISRO from the Satish Dhawan Space Centre SHAR (SDSC SHAR), Sriharikota (Andhra Pradesh), India's Spaceport on the southeast coast of the Indian peninsula. The anticipated launch readiness date is January 2024. NASA-ISRO Synthetic Aperture Radar (NISAR)
 i. NISAR, the joint NASA-ISRO Earth-observation mission, will map the entire globe in 12 days and provide reliable spatial and temporal data for analyzing changes in Earth's ecosystems.
- 4. Skye Air launches "Skye UTM", India's First Traffic Management System for Drones: Skye Air Mobility Private Limited(Skye Air), a Gurugram (Haryana)-based drone solutions provider, launched India's first traffic management system for drones, named "Skye UTM". Skye UTM, was launched in the presence of Nitin Gadkari, Union Minister of Road Transport and Highways. The system, Skye UTM, will allow drone operators to plan routes, make flight plans and assess risks before running drone-based operations in India.

The Player of the Tournament or Most Valuable Player (MVP) title was grabbed by England captain and stellar all-rounder Grace Scrivens.

- 3. MP CM Shivraj Singh Chouhan launched Ladli Bahna Scheme to Provide Rs 1,000 Per Month to Poor Women: Shivraj Singh Chouhan, Chief Minister (CM) of Madhya Pradesh(MP), launched a new scheme 'Ladli Bahna' to provide Rs 1,000 per month to women from financially poor backgrounds in Madhya Pradesh. CM noted that a sum of Rs 60,000 crore will be spent on this scheme over a period of 5 years. The announcement was made during a programme on the banks of the Narmada River in Narmadapuram, MP.
- 4. AP CM Jagan Mohan Reddy declares Visakhapatnam as the New Capital of Andhra Pradesh: Chief Minister (CM) of Andhra Pradesh, YS Jagan Mohan Reddy, stated that Visakhapatnam will be declared as the new capital of Andhra Pradesh during the International Diplomatic Alliance Meet, a curtain-raiser event for the Global Investors Summit, held in New Delhi, Delhi. He also announced that the government of AP will be organising the Global investor Summit in Visakhapatnam on 3rd-4th March 2023. In 2019, after YS Jagan Mohan Reddy took charge as the CM, the government decided to develop 3 capitals Visakhapatnam as the executive capital, Amaravati as the legislative capital and Kurnool as the judicial capital. In March 2022, the AP High Court ruled against 3 capitals and directed the government to develop Amaravati as AP's capital. The state government has filed a petition in the Supreme court challenging the High court order. The case against the HC ruling is still pending in the supreme court.
